Effective engagement processes with communities



In the spirit of feedback to effect change:

- unlike full-time council staff, communities have little time to engage. We suggest they need facilitation to do so effectively
- Website and search function (inadvertently) conceals the information of interest amongst a huge amount of other (very detailed) information.
- Tables of proposed expenditure under programmes (e.g. Land Drainage Programme) need to be supplemented: weblinks to projects on web? Or suburb summaries?
- Effectiveness of existing communication strategies for communities?

Preface

CCRU is committed to supporting community engagement and consensual adaptation to the effects of climate change. We are a community partner with Regenerate Christchurch in their South New Brighton and Southshore Project, as well as a community interlocuter with Christchurch City Council (CCC).

The recent changes within Regenerate Christchurch, and now a 'pause' by Regenerate Christchurch has caused widespread concern amongst key stakeholder groups and communities. This document has been informed by informal conversations with local residents and some other stakeholders. Due process is underway for it to be formally considered by Community Boards and Residents' Associations.

This document concerns the Southshore-South New Brighton Project area and represents a community submission to Regenerate Christchurch to assist them as we all remain in this period of 'pause', and to assist the adaptation process forward after the 'pause' along the agreed *Howteam* pathway.

A draft of this document was pre-released to Regenerate Christchurch and Christchurch City Council for their comments, and CCRU wish to thank both organisations for their useful feedback.

Unique Christchurch




Christchurch Earthquake Sequence (2011-2013), impact most severe in East
Capacity for communities to cope with stress over-estimated, East lowest
wellbeing in City...note effect of March atrocity.

Pre-Adaptation

- Repair of Community and Social Capacity
- Physical Repair where feasible
- Using strict economic criteria alone (ignoring social impacts) increases risk and leaves assets to degrade
- Repair of Earthquake damage required to allow communities to move to adaptation

Adaptation



- Sea level rise and flooding is an issue for our city, including the East.
- Focus is next 1-2 human lifetimes ONLY
- Optimum adaptation Cost–Benefit Ratio is 1:9
- Optimum Adaptation reduces risk and lowers cost

Recommendations

Repairing earthquake damage and improving social wellbeing and resilience of the community

- Repair damaged estuary-edge (Southshore) and make decisions about areas of South Brighton
- Reconnect suburbs to New Brighton, City and Ōtākaro Avon River Corridor with estuary-side cycle-walking track, 0.5m hybrid ecosystem protection
- Adaptation Research and Mandate
